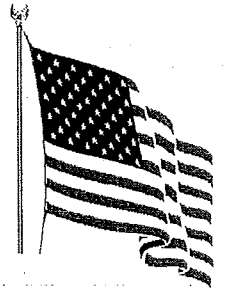


Vietnam Veterans Group of San Quentin

Chairman Beavers: Thanks our guest for their participation, J.Lynn Manley, Steve Emrick, and LtCol Sunny Campbell USMC.




